- ___ That a child is truant or has willfully & repeatedly violated lawful school rules
- ___ That a child is ungovernable
- ___ That a child is a runaway
- ___ That a child has repeatedly possessed or consumed intoxicating beverages, or that he has misrepresented or deceived his age for the purpose of purchasing or receiving such beverages from a person, or has repeatedly loitered around any place where such beverages are the principle commodities sold or handled.
- ___ That a child has committed an offense applicable only to children.
- ___ That a child under ten years of age has committed any act, which if committed by an adult would be a crime under any federal, state, or local law.
- ___ That a caretaker has caused, encouraged, or contributed to the child's behaviors enumerated in Article VIII or to the commission of delinquent acts as defined in Title VII.
- ___ That, after notice, a caretaker has willfully failed to attend a meeting with the child's teacher, school principal, or other appropriate school employee to discuss the child's truancy, the child's repeated violation of school rules, or other serious educational problems of the child.
- ___ That a child has been found incompetent to proceed with a delinquency matter under Art. 832 et seq.
- ___ A child found to have engaged in cyber bullying.
